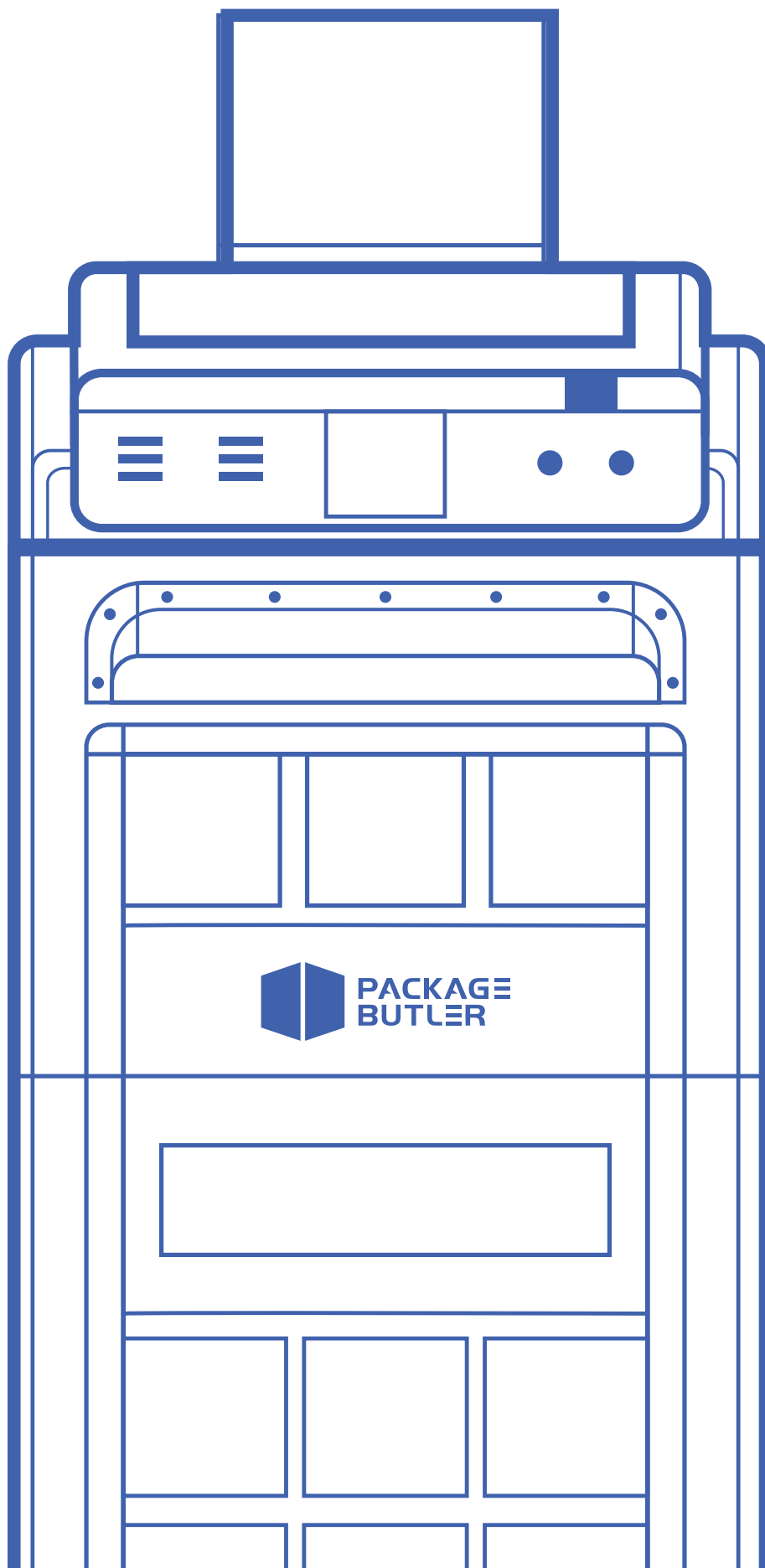

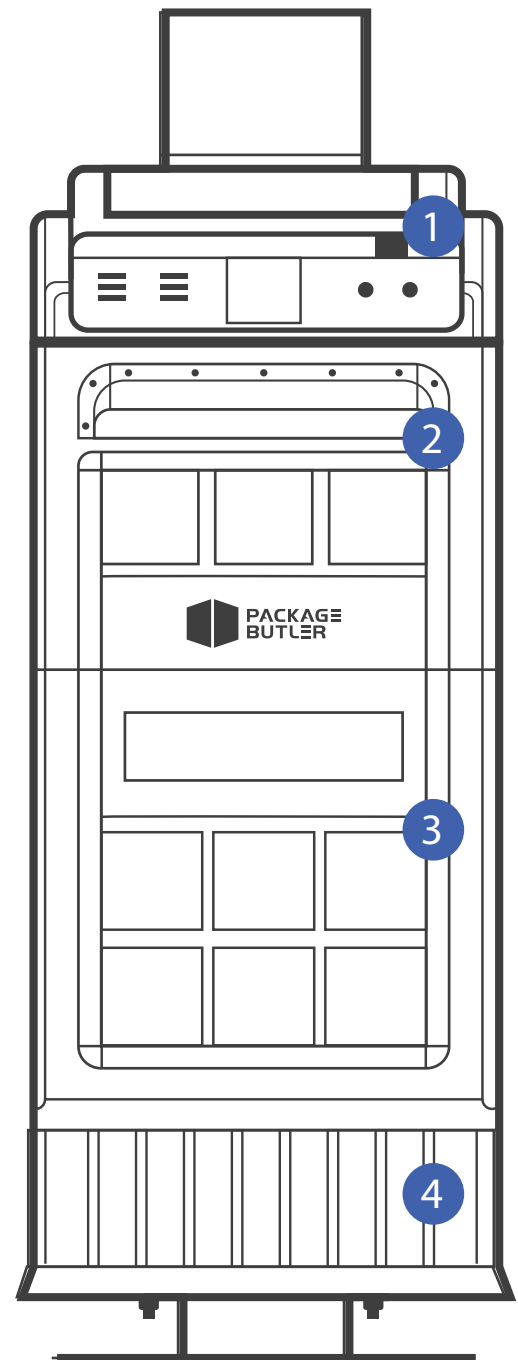

4. Shipping Compartment

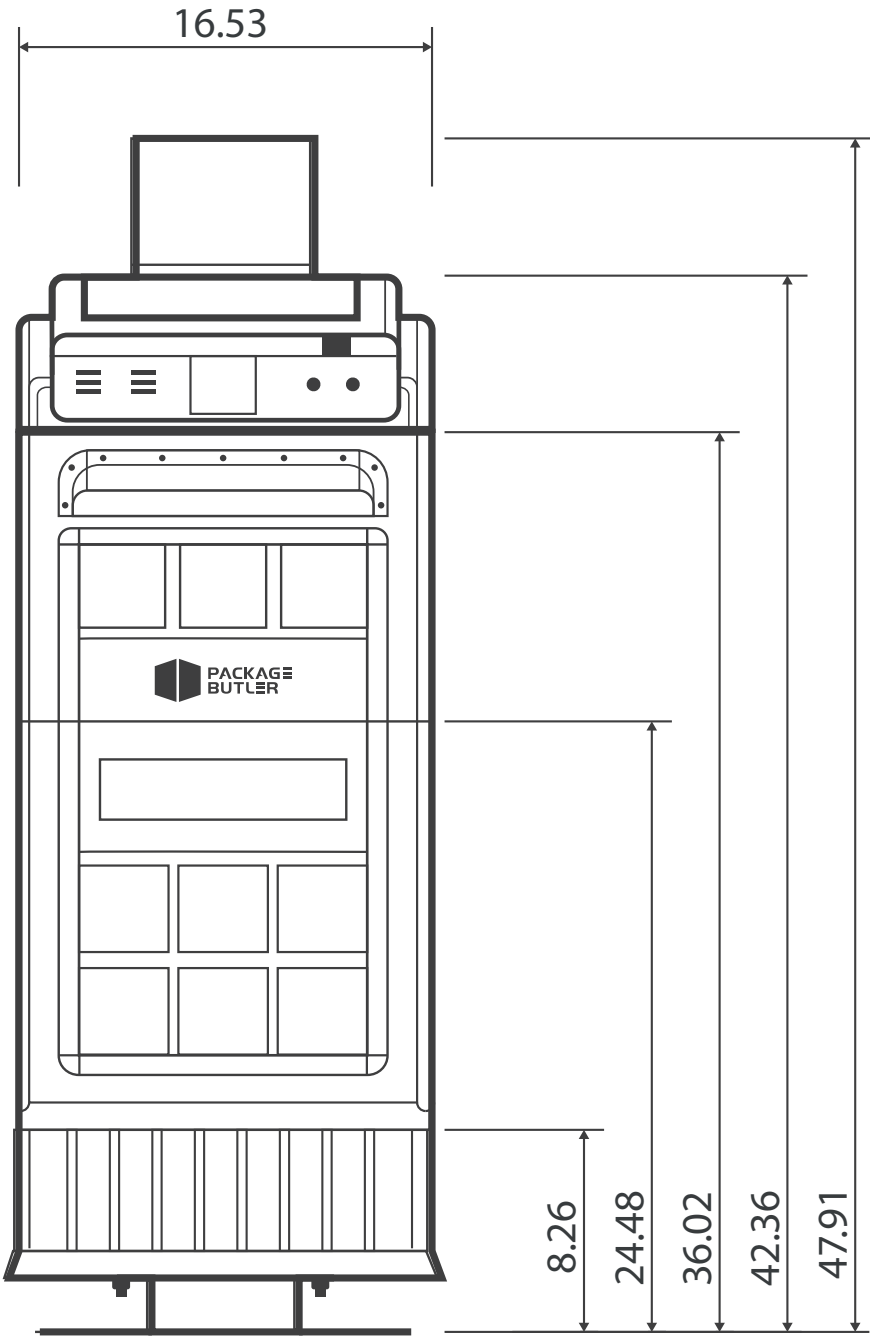

3. Tap "CONTINUE" and choose "Wired" to finish the process.

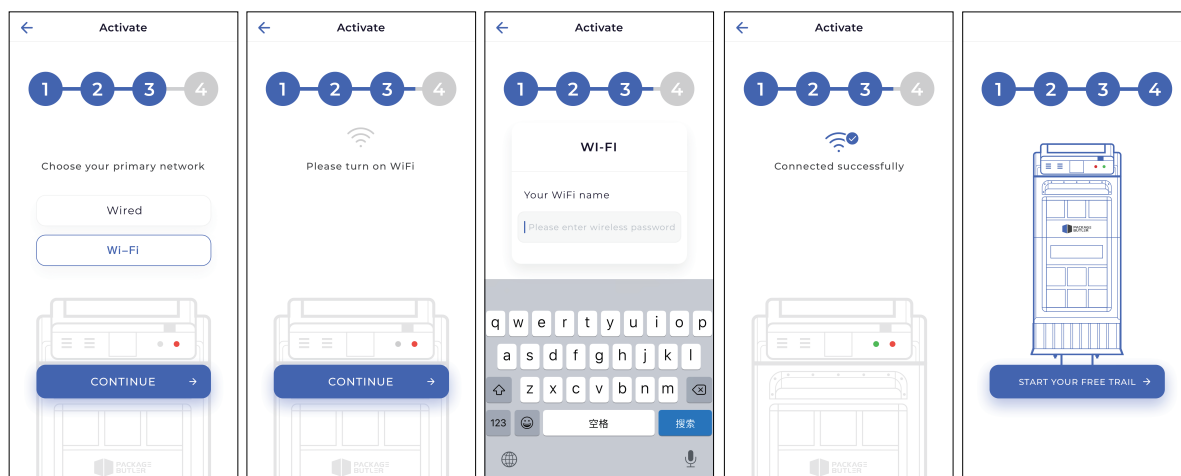
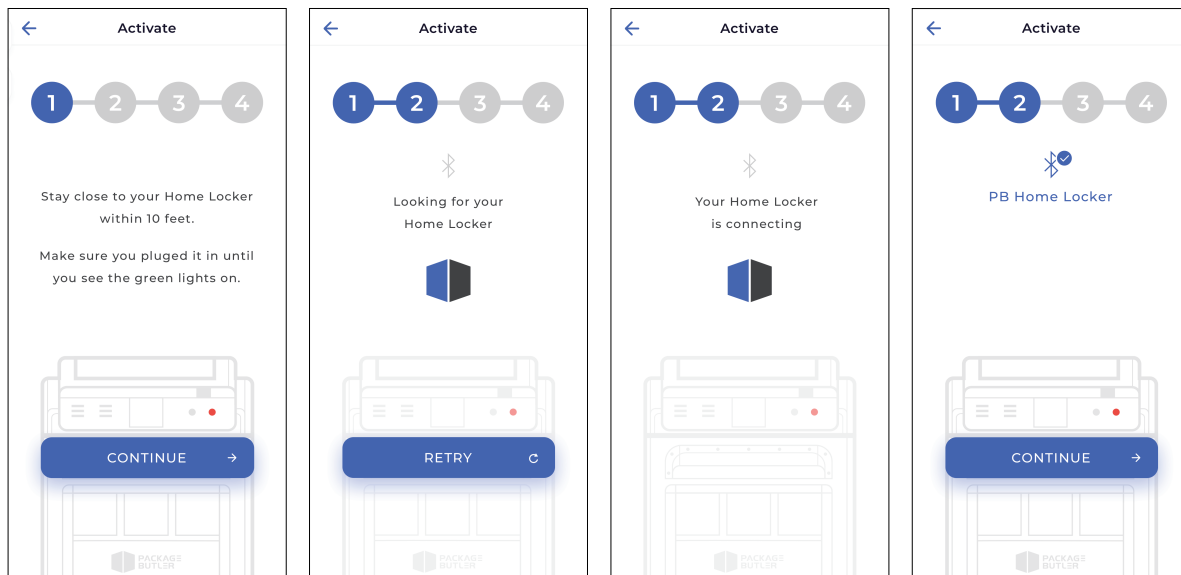

WiFi connection

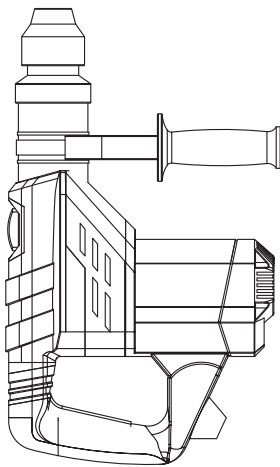

4. Make sure your WiFi is on and your phone is connected to it. enter your WiFi password, wait till the process is finished.



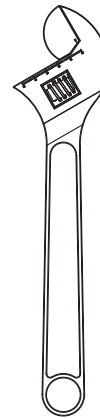
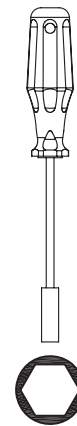
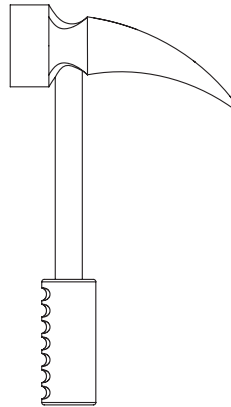

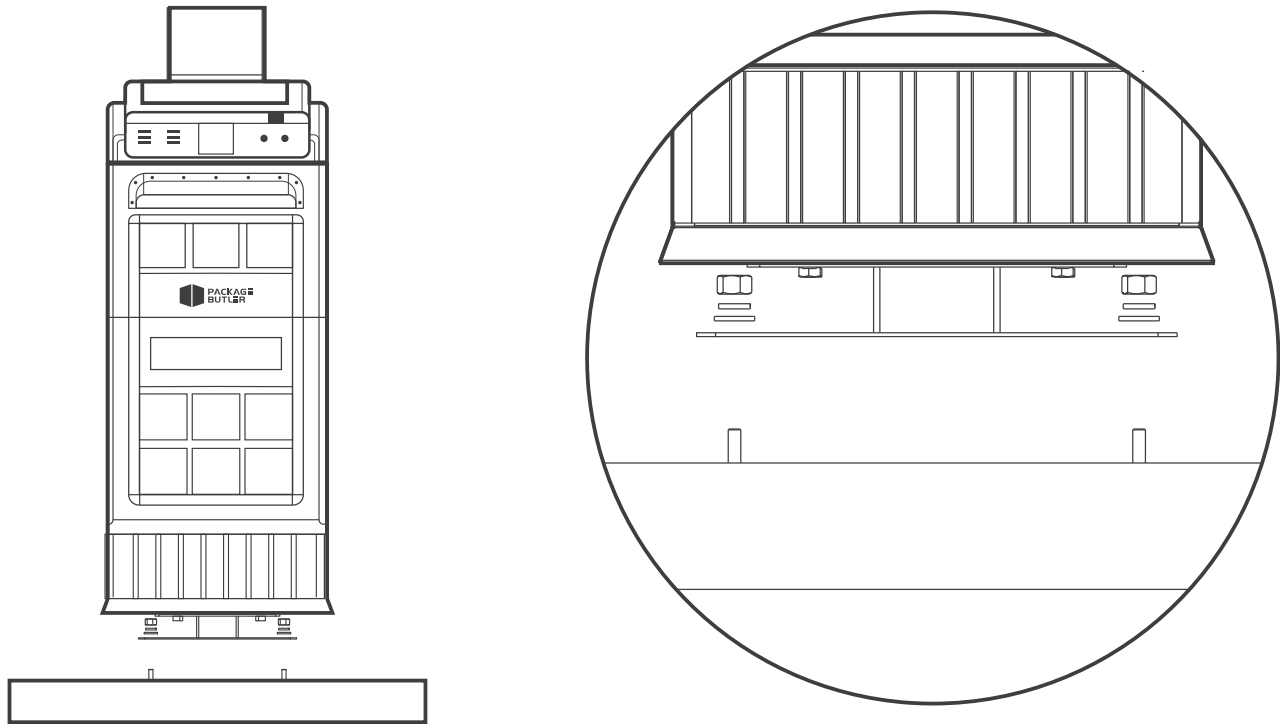
Instructions

1. Choose installation location and gather tools.
 - Adjustable wrench
 - Impact drill
 - Pen
2. Line up the marked paper with the installation location for drilling accuracy.
3. Insert anchor screws.

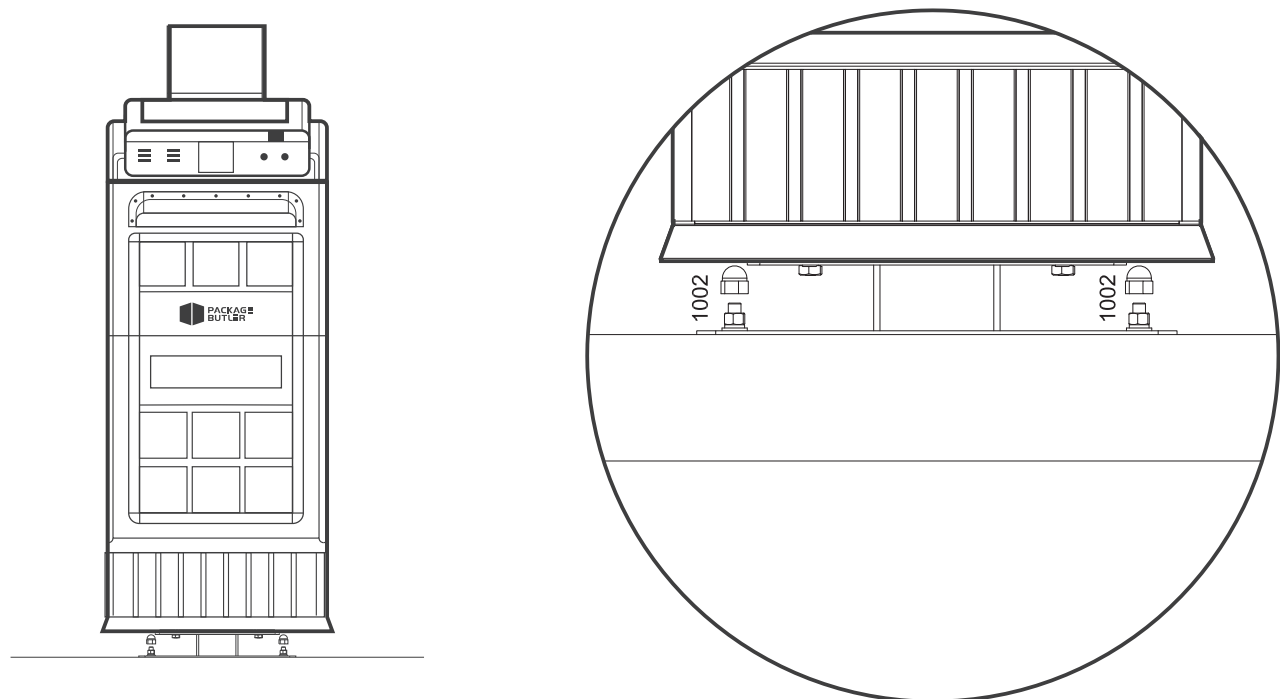

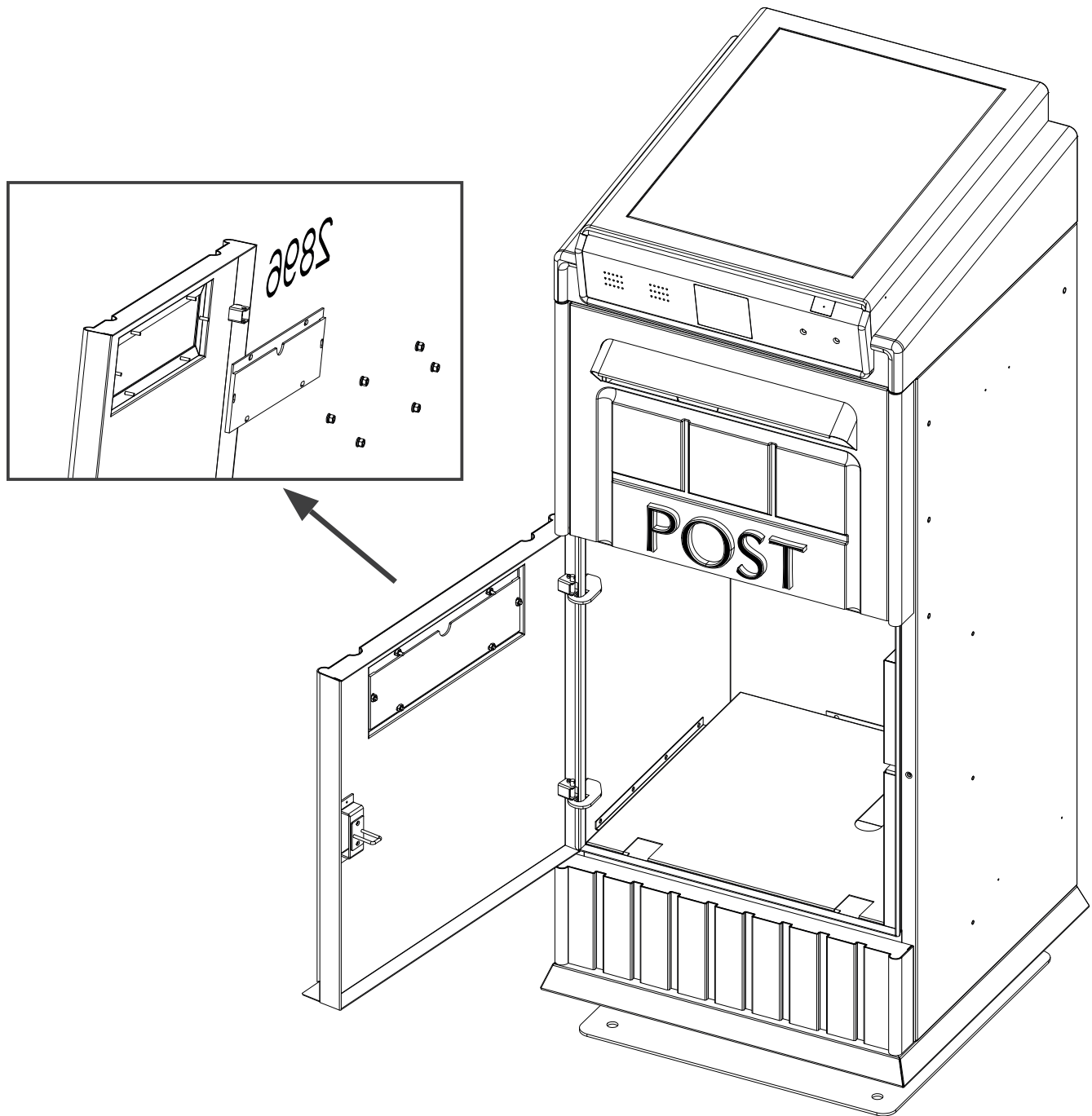
4. Move the locker to the mounting position. Drill the four expansion screws into the four mounting holes at the bottom of the locker.



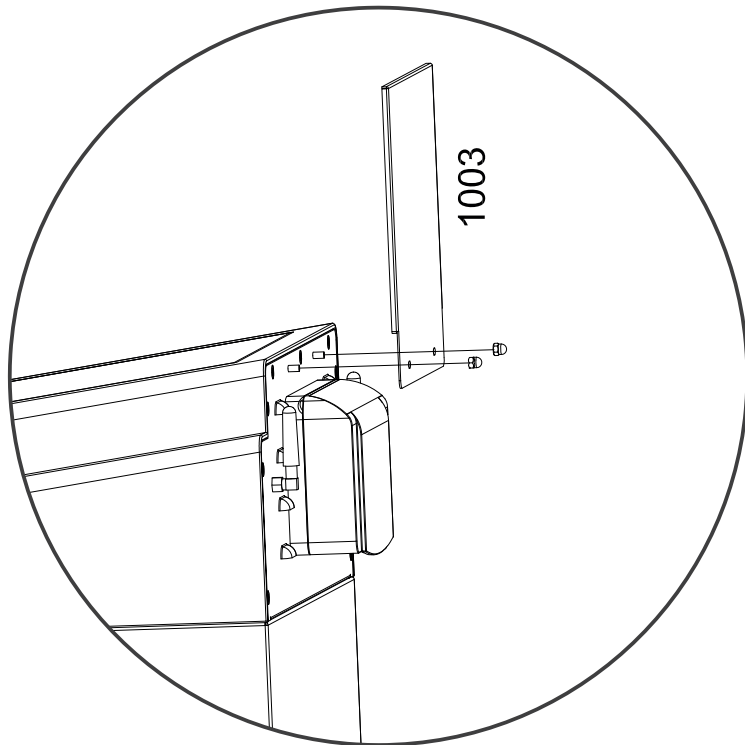
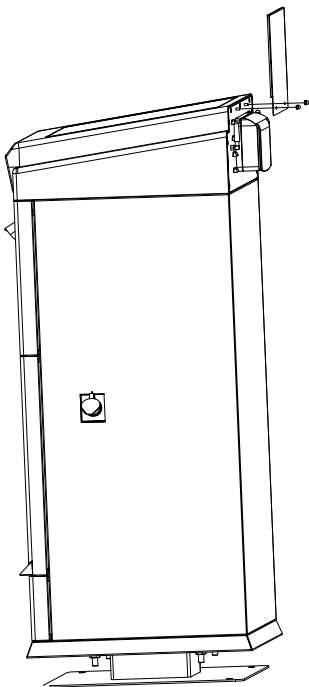
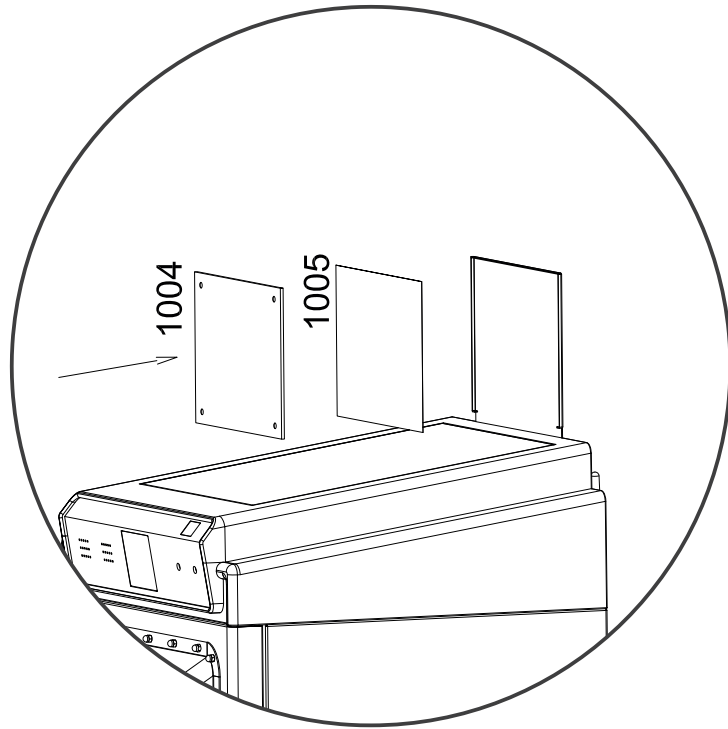
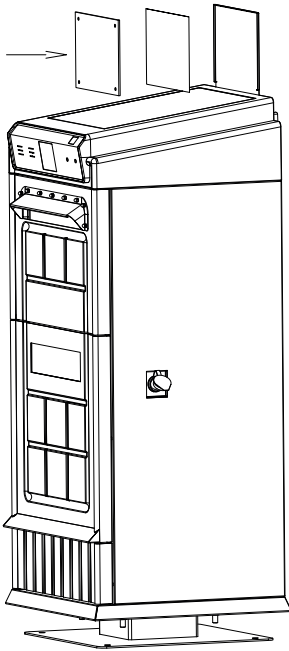
5. Use the adjustable wrench to tighten the expansion screws, holding the cover in place.



6. To use the number plate, open the pick-up door and insert the number plate from the inside



7. To customize the board, [instructions].

1. Delivery: How do carriers deliver my package?

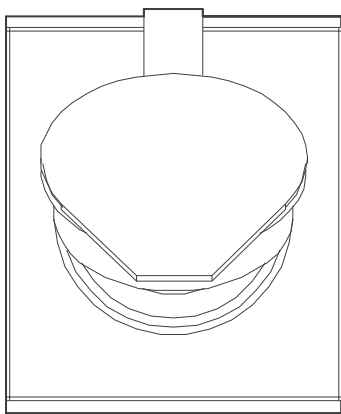
Use the scanning window to scan the barcode.

Open the door and place the package in the locker compartment.

Emergency Lock Opening

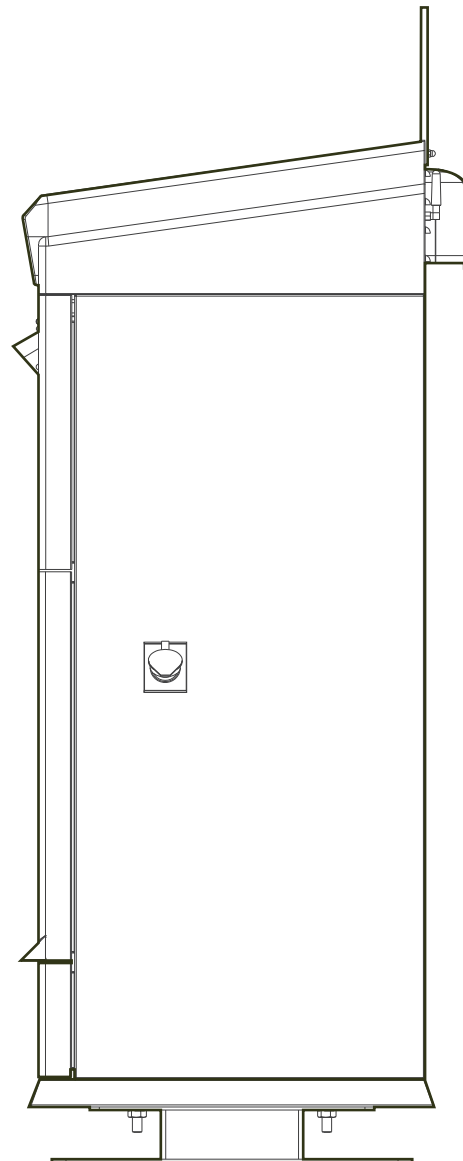
2. Pick-Up: How do I pick up my package?

Receive package delivery notification from Package Butler Home app

Tap the big round button in the middle of the home page of Package Butler Home app to retrieve your package. Make sure you're in front of the device when you do that.

Open the door and retrieve the package.

Close the door.



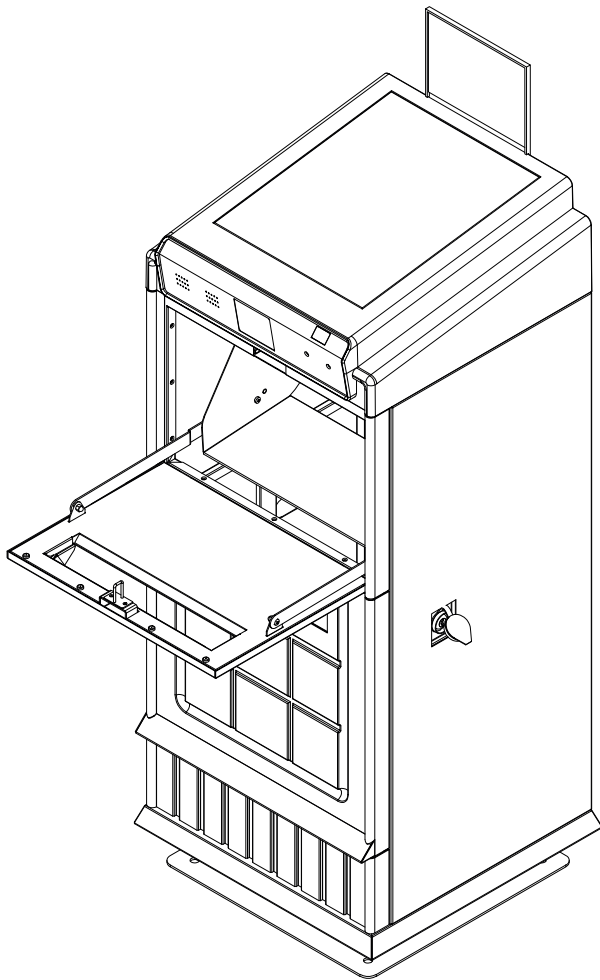

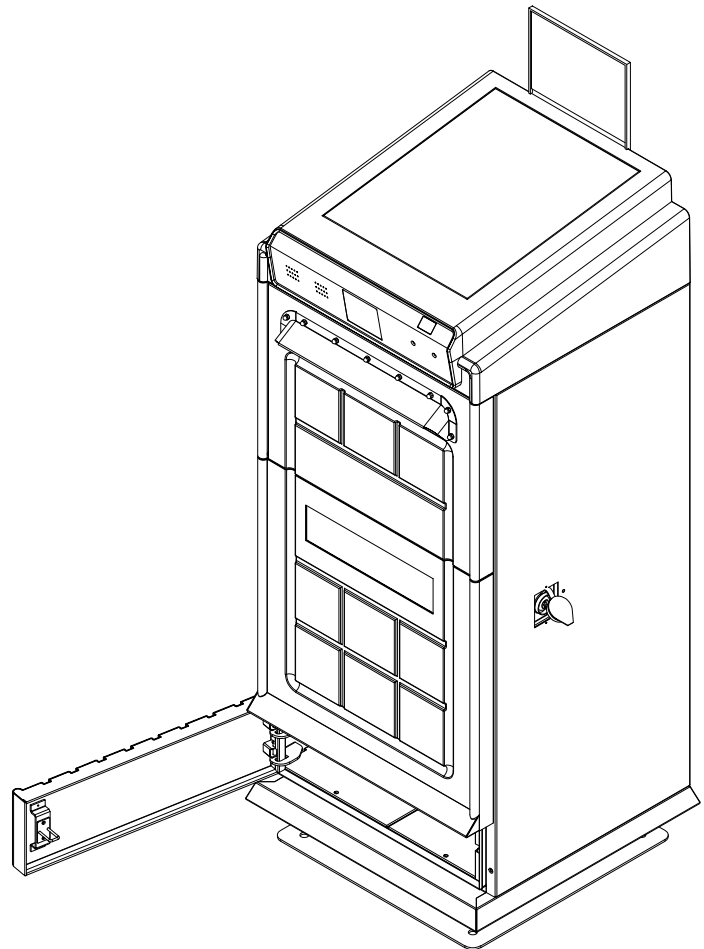

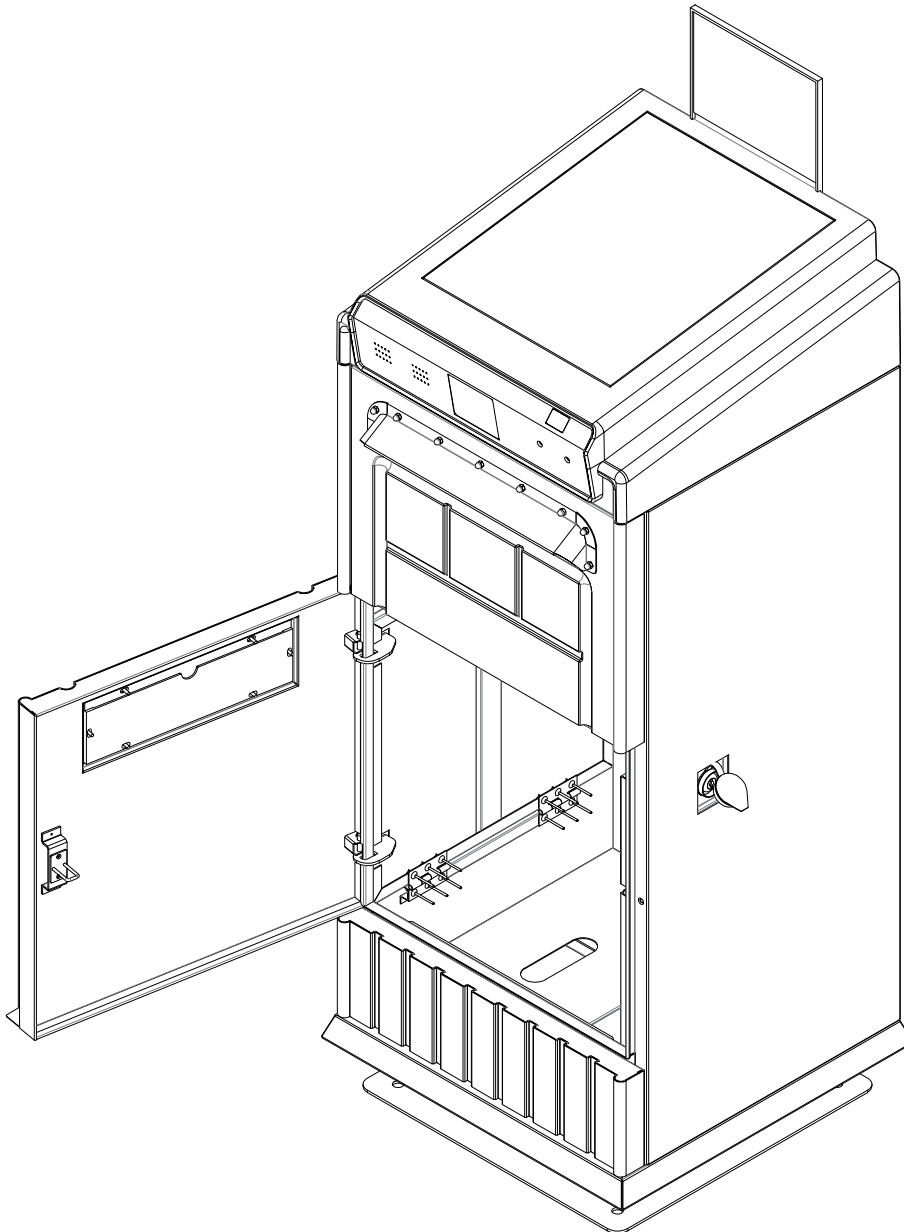

To adjust the divider:

The right end of the divider plate has a fixed butterfly screw. Lift it to the left side of the cabinet to secure it in place.

To use the shipping box with no divider, drop the plate down.



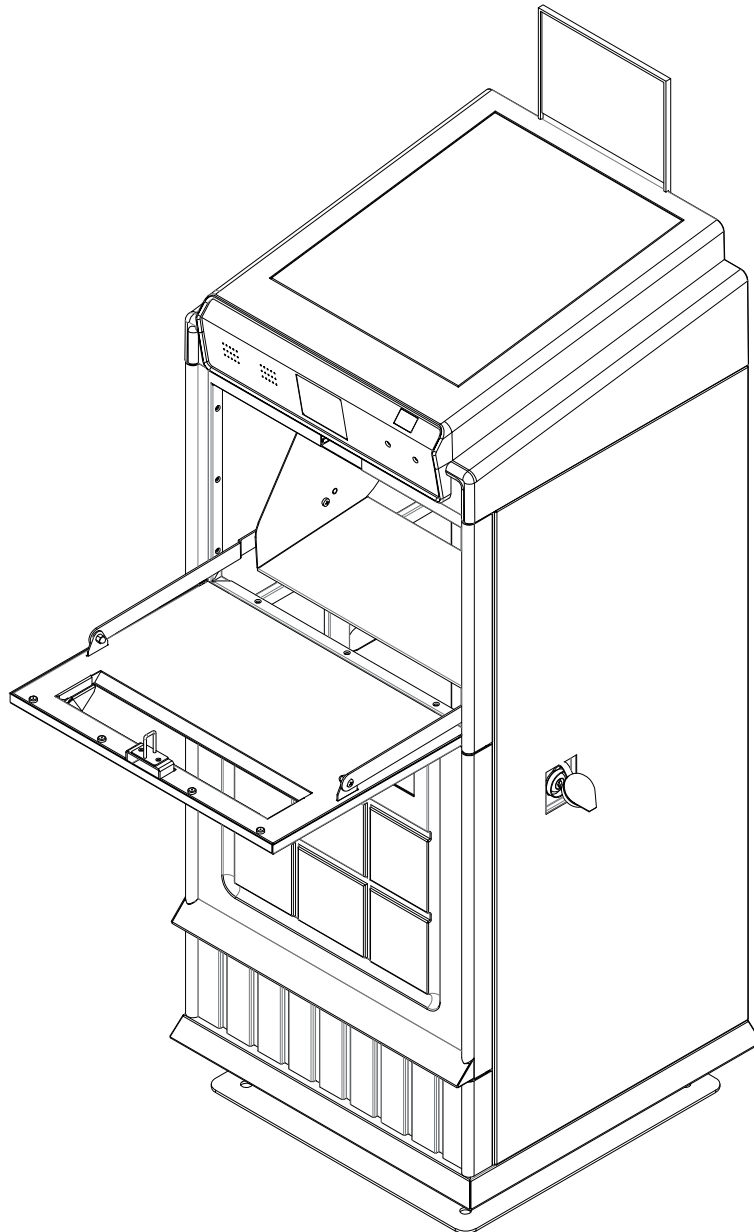
STORAGE AND SECURITY

Security Overview: Put a Stop to Neighborhood Package Thieves

The interior of the Home Locker contains an anti-theft package hopper. When the locker door opens, the package hopper flips over to block the package from a potential theft. When the door closes, the cargo hopper flips again,

allowing the packages to be smoothly dropped into the storage box for retrieval.

The locker's surveillance camera monitors 24/7, and its memory storage lasts for 7 days.



TROUBLESHOOTING

Installation and Registration: Set-Up Not Going as Planned?

Can I install the Home Locker on uneven ground?

If the Home Locker sits on uneven ground for a long period of time, it may become difficult to open the door. We recommend installing the locker only on even ground.

Some of my accessories are missing or damaged. What do I do?

If some of your Home Locker accessories are missing or damaged, please contact customer service and we will replace the accessory parts as soon as possible.

What if the power cord is not long enough?

The Home Locker power cord is 4.9 ft and should connect directly to the power source. Please contact customer service or contact a licensed electrician to extend the power cord. Please do not attempt to extend the power cord by yourself.

What do I do if the internet won't connect?

Please check for the Wi-Fi signal on your phone and review the instruction manual to make sure you've followed the proper connection process. If you still can't connect to the internet, please contact customer service.

What surface does the ground need to be where I install my Home Locker?

Package Butler recommends installing your Home Locker on concrete that is 42.5 in dense.

What if the power indicator light does not glow when the power cord is connected?

Please make sure the outlet is connected to power. If the outlet has power, please contact customer service and we will send you a new power cord.

My Bluetooth won't connect. How do I complete the registration process?

Please double check that the Bluetooth on your smartphone is turned on. If Bluetooth is turned on, but not able to find the Home Locker's signal, please contact customer service.

TROUBLESHOOTING

Package Pick-Up: Backup Plans for Opening Your Locker

I wasn't able to open the locker with the app. How should I fix this?

Please make sure that you have signed in and activated the device, and your locker is plugged in and connected to internet. Please contact our customer service if it still doesn't work. You can always use the emergency keys to open the locker.

I tapped the unlock button in the app and heard the opening sound, but the door is stuck. What should I do?

If the door is stuck due to physical damage, please contact customer service for assistance.

Package Delivery: Help for Carrier Holdups

How do carriers open the locker door if scanning the barcode doesn't work?

If scanning the barcode does not open the Home Locker door, carriers can manually type in the unique package code to open the door. If the issue persists, contact customer service.

A carrier successfully scanned the barcode, but the locker door was stuck. How do I get the door open?

If the door is stuck due to physical damage, please contact customer service.

What should carriers do if the locker is already full when they attempt to deliver a package?

Carriers should follow standard carrier procedure for making a second attempt at delivery.

What if a package is too large to fit in the locker?

If a package is too large to be delivered to the Home Locker, carriers should follow standard carrier procedures for package delivery (front step, etc.)

PRODUCT SAFETY

Safety Warnings: Keep You and Your Home Locker Safe

To work properly, the Home Locker must be connected to a power source and the internet. If not, the locker door may not open properly, and your package information may not update accurately.

Minimum power for proper functioning is 110V. If the power source is less than 110V, the locker may malfunction and there is risk on fire.

The HomeLocker performs best between 14F-105F. Be careful sending perishables outside of this range.

Do not use corrosive liquid to wipe the equipment. The locker may malfunction and there is risk of fire

The equipment must be bolted to the ground to ensure the safety of the equipment and package. Leaving the Home Locker unbolted may lead to package theft and damage to product and/or persons.

Do not immerse the Home Locker in water, as it may result in fire and damage to product and/or persons.

As described in Section 6.4 below, upon termination, equipment must be returned to Package Butler or charges will apply. Subscription prices may change from time to time and by continuing to use Package Butler you agree to the price change.
- 6.2 Subscription Fees must be paid using a lawfully issued credit or debit card for which you have authorization to make a charge. Package Butler reserves the right to block access to your Account until a valid credit or debit card has been provided to cover all charges incurred by you.
