



PARENTAL CONSENT AND RELEASE

I hereby completely release, discharge, and agree to hold harmless Vego Garden, Inc., its officers, directors, employees, assigns, licensees, designees, and all persons acting under its permission or authority, from any and all claims I may have relating to my Child’s participation in the Program, Vego Garden’s collection of my child’s personal information, or the use of the Materials in accordance with the Program and my consent, including without limitation: defamation, right of publicity and invasion of privacy. I have read this release and am fully familiar with its contents.
