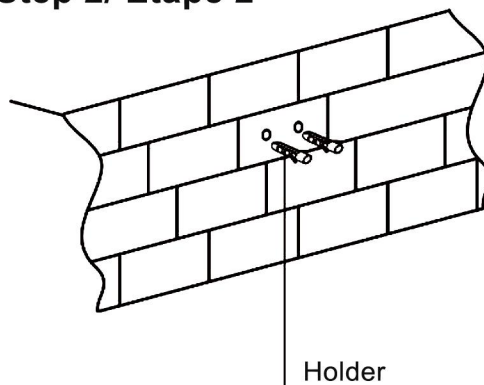

Step 1/ Etape 1



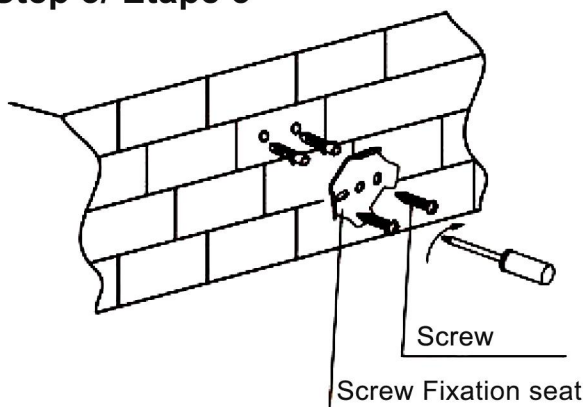
Refer to product size, drill 6mm holes on the appropriate position of wall surface.

Step 2/ Etape 2



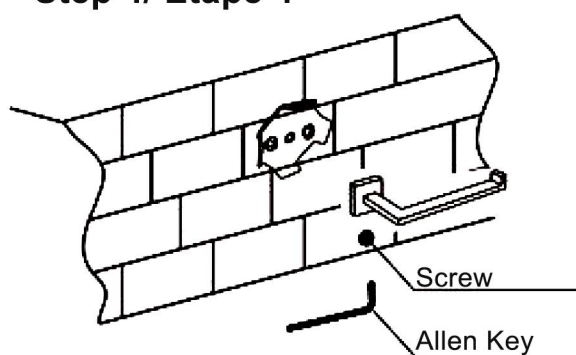
Hit holder into the hole.

Step 3/ Etape 3






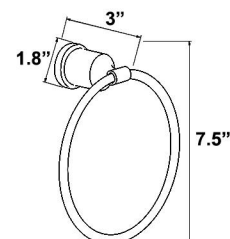
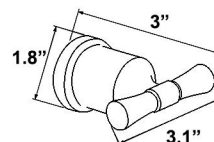
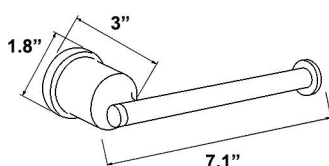
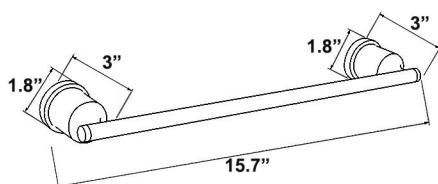
Use Cross screwdriver to tighten screw and fix bracket on the wall.
