

- 5. DC Power Port




## **Preparation**

### Prior to use, check the condition of the machine and accessories:

- a. No damage on power charger
- b. Battery power is sufficient

### Charging

- 1. Open the cover of the DC power port on the main unit.
- 2. Insert the plug of the power charger to the DC port.
- 3. During charging, the battery icon on the LCD screen flashes and shows the increasing battery power. The icon stops flashing when fully charged.
- 4. The massager cannot be used while charging. If the unit is turned on while being charged, it will prompt the self-protection program and the massager will automatically turn off.
- 5. The recommended charging duration is 2-3 hours.



### Wear

- 1. Put on the main unit where it will cover the eyes.
- 2. Adjust the elastic band to achieve the most comfortable fit.

### **Operation**


### Power On

Press and hold the Button.

Preset default is SLEEP mode.

### **Mode Selection**

Quick Press the Button to select mode.



### **Power Off**

Press and hold the (1) Button again

### **Precautions**

# Please read this section carefully for correct and safe use of this product.

- 1. Please read the manual carefully and operate accordingly.
- 2. Children under 7 years old cannot use the massager.
- 3. This massager should not be used by:
  - a. People who suffer from brain disease or have undergone brain surgery
  - b. People who are suffering from glaucoma, retinoschisis or other serious eye diseases
  - c. People who have physical or mental disorder
- 4. Take off contact lenses/eye glasses before use.
- 5. Put on/wear the unit first BEFORE turning the power on.
- 6. Do not use while walking or driving.
- 7. Keep your eyes closed for a few seconds after use, then open them slowly.
- 8. Keep the massager away from humidity, heat, and/or corrosive gas.
- 9. If the massager will not be used for a long time, remove the batteries to avoid battery leakage.
- 10. This massager features heat compression. Individuals who are incapable of or do not ordinarily feel heat/cold sensation should use this device with caution.
- 11. To clean, wipe with aseptic cotton and alcohol. Do not wash or immerse in water.
- 12. This product is not a substitute for healthcare professionals' advice and treatment. In case of doubt or if necessary, please consult your healthcare professional.



### **Precautions**

- 13. This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions:
  - (1) this device may not cause harmful interference, and
