simplesurance is an Appointed Representative of Richdale Brokers and Financial Services Ltd who are authorised and regulated by the Financial Conduct Authority (FCA) under FRN 983167.

simplesurance is a Branch of simplesurance GmbH and acts as an agent of underwriters for receiving money from customers, settling claims, and handling premium refunds.

simplesurance GmbH is a company registered in Germany with the Chamber of Commerce and Industry (CCI) of Berlin as an insurance agent with a license in accordance with Section 34d para. 1 of the Trade Commerce and Industry Regulation Act (GewO) with its trading address at Am Karlsbad 16, D-10785 Berlin.

CONFLICTS OF INTERESTS AND TRANSPARENCY

Participation

simplesurance does not hold a direct or indirect share of more than 10% of the voting rights or capital of an insurance company or of the mother company of an insurer. Allianz Partners SAS (7 Rue Dora Maar, Saint-Ouen) holds a share of 100% of the voting rights or the capital of simplesurance GmbH, mother company of simplesurance. Allianz Partners SAS is the holding company of the insurer AWP P&C S.A. and is ultimately owned by Allianz SE (Königinstraße 28, München).

simplesurance does not conduct insurance distribution business exclusively with one insurance undertaking and does not give advice on the basis of a fair and personal analysis.

Commission

simplesurance receives a commission from the respective insurer for a successful mediation of an insurance contract. This commission is already included in the insurance premium to be paid by the customer and therefore does not have to be paid separately from the customer, simplesurance does not receive another contribution as compensation for the intermediary services. Therefore, the compensation does not consist of a connection of commission and another contribution.



Pricing and premium

The insurance contract is subject to the payment of a premium, the amount of which as well as the various payment options available are displayed before the conclusion of the insurance contract.
