### **International Business Procedures**

- All money transactions will be in U.S. currency. All documentation will be in English.
- Opening order must be a minimum of US\$10,000 shippable merchandise. Subsequent orders must be US\$1,000.
- Pictures of your facility are needed to establish an account. Dynam RC will ask for updated pictures occasionally to update account.
- The original signed distributor application must be received prior to shipment of first order.
- All orders must be paid prior to shipping. Method of payment is wire transfer. Buyer must pay wire fees from originating bank. Dynam will pay wire fees from our bank and intermediary banks, if applicable. Initial order must be paid by wire t/t. Subsequent orders can be paid by Visa or MasterCard if the shippable amount is not greater than \$10,000.
- Payment is due 10 business days after placing an order. If payment is not received within 10 business days, merchandise from the order can be offered to other customer's in need if the stock availability is low on a given item.
- Shipping cost is the responsibility of the customer. This charge will be added to your invoice after the order is picked and ready to ship. The shipment of hazardous materials such as products containing flammable, combustible chemicals or materials must be shipped via a certified freight forwarder and are subject to handling charges.
- Certain product export restrictions may apply. These policies and procedures may be modified at anytime at the discretion of Dynam RC, Inc.
- In accordance with China Export Administration Regulations, diversion of product contrary to China law is prohibited. Illegal Diversion will result in the permanent deactivation of your account. You may be subject to additionally liability under international law.
